### 13.1 DEFINITION

- (1) "Representative teams" means those teams fielded by the Association in community football regional, zone, country or state championship tournaments.

### 13.2 MANAGEMENT

- (1) Representative teams will be managed by the Association who will:
  - A) Prepare a budget;
  - B) Collect any income;
  - C) Pay any expenses;
 associated with representative teams.

### 13.3 PAYMENTS

- (1) Representative team coaches will receive an honorarium of \$500 per tournament.
- (2) Representative team managers will receive an honorarium of \$250 per tournament.
- (3) To limit expenditure only 1 coach and 1 team manager will be appointed to each team.
- (4) For tournaments held in Ballarat, coaches and team managers will receive half of the standard honorariums.
- (5) Regional coordinator/s will receive an honorarium of \$125 per team per tournament.
- (6) Referees will receive travel expenses of \$125 per overnight stay.

### 13.4 PLAYER ELIGIBILITY

- (1) Only players who have regional registration with an Association Cub will be eligible to represent the Association in tournaments.

### 13.5 PLAYER REGISTRATION

- (1) Player registration fee for representative teams is given in Section 10.1.3
- (2) Any player with outstanding registration or other charges associated with a representative team is ineligible to play in a representative team until all outstanding amounts are paid.
